RE: Proceedings on Remand in *Scotts Valley Band of Pomo Indians v. United States Department of the Interior*


Dear Director LaCounte,

We write to express our significant concerns regarding the Proceedings on Remand in *Scotts Valley Band of Pomo Indians v. United States Department of the Interior*. Our concerns echo those that have been repeatedly raised to the Department of Interior by the Yocha Dehe Wintun Nation (Yocha Dehe) and Solano County but have seemingly gone unacknowledged by your agency.

As you know, the matter at hand involves the Scotts Valley Band of Pomo Indians' (Scotts Valley Band) proposal to take land into trust in Vallejo, California for the purposes of developing a gaming facility and housing. However, Vallejo is almost 100 miles away from the Scotts Valley Band's existing government headquarters and tribal residences in Clear Lake, California. Furthermore, Vallejo is within the ancestral lands of the Patwin people, which includes Yocha Dehe. Yet Yocha Dehe has been inexplicably excluded from the consultation process. Such a proposal is extraordinary and requires a deliberate and inclusionary approval process. The exclusion of Yocha Dehe unfortunately typifies the secretive process by which this proposal and related environmental review has been prepared and considered, the opaqueness of which undermines the government-to-government relationship between sovereign tribal nations and the US Government.

The Scotts Valley Band's proposal is unprecedented and a requires a deliberate and inclusionary approval process. We strongly urge the Department of Interior to meaningfully engage the Yocha Dehe Wintun Nation and other affected or interested Tribal governments in these proceedings.
